

Fromin source

From a geographical perspective, the territory in the surroundings of the abstraction well is a part of the Ceska Lipa Region Basin, which was formed by the tectonic depression of strata in the Bohemian Cretaceous Basin. The groundwater stems from quartz sandstone strata of the Jizera Formation with marked block cleat (so-called sandstone blocks) from depths of 160-280 m below the existing terrain level. The Formation of quartz sandstone relates to the deposit of predominantly sandy material in a cretaceous sea over the course of 10 million years. During this period, the deposits of sand reached a thickness of up to 400 m. The age of the strata, which is the source of groundwater from the well, is estimated at 88-90 million years.

The source of this underground water is atmospheric precipitation (originally a glacier considering the age of the water), which penetrate into the horizon of the water-bearing layers of sandstone blocks from the territory of the Lusatian Fault, where sandstone blocks protrude to the surface. This area is about 9-10 km northeast from the abstraction well. The water-bearing horizon of quartz sandstone blocks is slightly tilted from the northeast to the southwest and is isolated from the surroundings on the top and at the base by impermeable clay stone and marlite. Thus the overlying impermeable strata create a so-called confining layer, which means the groundwater caught by the abstraction well below the confining layer flows out under the pressure of the water column in the water-bearing strata above the surroundings of the terrain. Water from atmospheric precipitation, which seeps into the slightly inclined sandstone strata, flows very slowly through gaps between sandstone grains and along the crevices in this sandstone until it finally flows into the erosion incisions of the Ploučnice River, from where the water naturally springs to the surface stream of the Ploučnice and its tributaries. The velocity in the horizon of quartz sandstone is very slow and corresponds to the order of values cm-m/year. Groundwater from the horizon of quartz sandstone of Middle Turonian age is much

younger than surrounding strata, through which it gradually flows. From a geological perspective, this groundwater is considered to be young. Its age, which was estimated based on velocity from the seepage point of atmospheric precipitation to the horizon of quartz sandstone in the area of the Lusatian Fault in the direction of the abstraction well, corresponds to approximately 15,000 years.

While the groundwater flows very slowly within the horizon of quartz sandstone of the Jizera Formation, the chemical properties of this groundwater are affected by leaching mineral elements from surrounding strata. Thus the groundwater has a neutral to slightly alkaline reaction, it is medium hard with a rather constant quality and corresponds to Ca-HCO_x type water. It is very high quality groundwater, healthy for the human body, free

of all harmful substances and satisfactory as natural spring water from all aspects.

The significance of huge and continually renewed sources of groundwater in the horizon of Middle Turonian quartz sandstone in the present time of constant pollution of surface water sources is on a European scale. In the territory of the abstraction site, which is situated in the eastern part of the built-up area of the city Česká Lípa, a 160 m thick horizon of clay stone and marlite separate this quality groundwater from the surface. These strata are impermeable in the case of any accidental penetration of polluted surface water from the built-up area of the city to the water-bearing horizon containing the quality groundwater and thereby forms a natural barrier against groundwater pollution.




The unique journey of Fromin water

In the last ice Age, the mountainous landscape of today's Northern Bohemia was covered by a glacier, the source of which was atmospheric precipitation.

FROMIN water has thus gone through all states. First it was vapour, then snow and ice. About 15,000 years ago, at the end of the Ice Age, it began seeping from the melting glacier into the horizon of the water-bearing layers of sandstone blocks, the age of which is estimated to be 90 million years. In this stratum of quartz sandstone, in which the water flowed between grains of sandstone and crevices at a maximum speed of 1 metre per year, mineral substances were leached into the glacier water that was free of minerals. Thanks to this very subtle enrichment of important minerals, FROMIN water has a neutral to slightly alkaline reaction.

The original quality of FROMIN water is protected by overlying impermeable strata, which create a so-called confining layer with a thickness of 150 m. Another source of important protection is created by the pressure from the water column, because owing to the slightly tilted sandstone strata the water flows from the abstraction well under pressure, which prevents hazardous chemicals and compounds produced by today's industry, and lifestyle from penetrating it.
